Canadian Solar did not immediately respond to a Reuters request for comment. Maxeon, which designs and manufactures Maxeon and SunPower brand solar panels, had filed a patent infringement lawsuit against Aiko Energy (600732.SS) in a Dutch court last year, escalating its legal battle with the Chinese solar panel manufacturer.

When did Canadian Solar go public?

With the company's acquisition of Recurrent Energy, Canadian Solar's total project pipeline reached 20.4 GW, including an increase in the late-stage project pipeline to 2.4 GW. In November 2006, the company went public (Nasdaq: CSIQ) at \$15 per share.
