Does Northvolt have a joint venture with Volvo Cars?

#### Who is Northvolt?

Northvolt is a leading supplier of sustainable, high-quality battery cells and systems, dedicated to delivering the world's greenest lithium-ion battery. Together, we have formed a joint venture, NOVO Energy to power the next generation of pure electric Volvo and Polestar cars.

Does Novo energy rely on a third party to produce a battery?

"Any battery production at NOVO Energy is dependent on third partyor other partner involvement," Volvo Cars said in its statement on Wednesday, while adding this would not impact its own vehicle rollout plan. A Volvo spokesperson declined to elaborate on potential partners.

#### Who owns Novo energy?

The Swedish carmaker, owned by China's Geely, said on Wednesday that it planned to invoke its redemption rights to take full ownership of Novo Energy from its current 50-50 partner Northvolt as the battery group had not "fulfilled its financing obligations".

What is going on with Volvo Cars & Northvolt?

19 February 2021: Northvolt investing US\$200 million in ESS gigafactory. Lithium-ion battery startup Northvolt will build a factory in Poland for assembling energy storage systems (ESS), with an initial output of 5GWh per year.

Northvolt said earlier this month that it has been selected as strategic lead supplier to Volkswagen for premium battery cells in Europe with the massive new deal, which runs for 10 years. Northvolt is building out a gigafactory in Sweden, called Northvolt Ett, from which it plans to produce lithium-ion batteries with a low carbon footprint.
