1.4.2. Phase 2: Microgrid Incentive Program . On April 6, 2023, the Commission adopted D.23-04-034 which establishes rules for the Commission's Microgrid Incentive Program. The Microgrid Incentive Program is a program that places community microgrids in disadvantaged, vulnerable communities to support populations impacted by grid outages.
