As part of the Registrar General's Department, the Jamaica Companies Office was originally created in 1975. It is responsible for the day-to-day administration of business names and companies.

Who registers a company in Jamaica?

The COJ registers local and overseas companies and individuals and firms carrying on business in Jamaica. It actively encourages voluntary compliance of companies and businesses with the Companies Act of 2004, the Companies (Amendment Act) 2013, the Registration of Business Names Act of 1934.

How do I register a business in Jamaica?

No need to come into the office, register your business anytime and anywhere you please with our new online registration portal. You can search for companies or business names registered in Jamaica. You can enter either the company's name or registration number. You can now request certified copies of registered documents.

How do I find a registered company in Jamaica?
