

When will the electricity exchange start in Bulgaria?

Where can I purchase electricity in Bulgaria?

In Bulgaria, customers can purchase electricity directly from generators or from holders of trading licenses, through bilateral contracts (2.4.3). The Commission for Protection of Competition (CPC) is the regulatory body dealing with competition matters in the electricity sector of Bulgaria (see paragraph 3.1.11 below).

How does the electricity market work in Bulgaria?

The electricity market in Bulgaria consists of inter-connectors transfer capabilities (capacity). Agreements on regulated prices may be entered between renewable energy generators and end-suppliers/public supplier. Agreements on free prices can be concluded between:

Who owns the electricity transmission infrastructure of Bulgaria?

In Bulgaria, the TSO (Transmission System Operator) currently owns the electricity transmission infrastructure, consisting of 110kV, 220kV and 400kV lines. The TSO is in charge of the operational regime planning and control of the electrical power system of the Republic of Bulgaria.

When was the Bulgarian electricity supply market fully liberalised?

The Bulgarian electricity supply market was fully liberalised on 1 July 2007. Customers who are connected to a high voltage grid buy their electricity from NEK, while those connected to a medium or low voltage grid buy from the distribution companies.

Who regulates electricity prices in Bulgaria?

Price control issues in Bulgaria's electricity sector fall within the competence of the Commission for Protection of Competition (CPC). However, the SEWRC is the regulatory body that is obliged to refer to the CPC if the respective matter is related to competition.
