Will Croatia build Europe's largest energy storage project?

Croatia is preparing to build Eastern Europe's largest energy storage project. IE Energy has secured EUR19.8 million (\$20.9 million) to develop a 50 MW storage system, potentially extendable to 110 MW by 2024.

Is Croatia ready for solar energy storage?

"There is immense scope for energy storage in Croatia, predominantly for battery storage." GlobalData says that Croatia is now on target to meet its 36.4% renewable energy target by 2030. However, its recent investment in energy storage has not been accompanied by rapid solar PV development.

How much electricity does Croatia produce in 2022?

The total production of electricity in the Republic of Croatia in 2022 was 14,220.5 GWh, whereby 63.7 percent (9,064.9 GWh) was produced from renewable energy sources, including large hydropower plants.

What percentage of Croatia's energy mix is renewable?

How many hydropower plants are there in Croatia?

Croatia has 28 hydropower plants of which 2 are reversible, 2 small size and 1 pumped storage. They are distributed in three production areas: North, West and South with one independent plant, and are HEP's most important source of renewable energy.
