Does Bermuda have a corporate income tax?

The Government of Bermuda is introducing a Corporate Income Tax (CIT) to apply to Bermuda businesses that are part of Multinational Enterprise Groups (MNEs) with annual revenue of EUR750M or more. The proposed CIT is expected to take effect in January 2025.
