

What is rerec's mandate under a new dispensation?

Under the new dispensation, REREC has an expanded mandate of spearheading Kenya's renewable energy drive, in addition to implementing rural electrification projects. Under section 44 (1) of the Energy Act 2019, REREC is mandated to undertake the following functions:

How many rural electrification projects have been completed in Kenya?

Under the REREC and Meru County Matching Facility partnership, 92 rural electrification projects have so far been realized at an estimated cost of 45 million Kenya shillings. 33 of these projects are completed while 59 are in progress.

What is rerec doing with Meru County government?

REREC further held a discussion with Meru County Government that will culminate in a Solar/wind hybrid Power Plant which will be in line with the Corporation's mandate of ensuring affordable and clean energy that is connected to the National Power grid.

Who are the key stakeholders of rerec?

County governments are key stakeholders of the Corporation as they collaborate with REREC through the Matching Fund programme which accelerates rural electrification in priority areas at the County and Constituency levels.
