Will French government ease subsidising rooftop solar projects?

The French government last week unveiled plans to ease the mechanism for subsidising rooftop solar projects and put a cap on the reduction of feed-in tariffs (FiTs) for larger projects.

How much does a ground-mounted solar project cost in France?

Broadly speaking, for ground-mounted solar projects located in mainland France, the FIT will be reduced from EUR 570 per MWh to EUR 30 per MWh. The minimum FIT will be in the range of EUR 18 to EUR 50 per MWh, and the average FIT will be around EUR 30 per MWh.

How do I apply for a MaPrimeRénov solar installation?

The demand must be made by submitting an official MaPrimeRénov dossier, and installations must be carried out by an RGE-certified tradesperson to be eligible. For the installation of thermal or hybrid solar panels that are used specifically for heating purposes, there is a reduced VAT rate of 5.5%.

Terms of the scheme that were to apply until 31 December 2024 are being extended by one year. Moreover, the level of aid that may be received changes from 1 January 2025.
