How many islands are in the British Indian Ocean territory?

Map of the British Indian Ocean Territory since 1976. The territory is an archipelago of 58 islands covering 56 square kilometres (22 sq mi). The largest island is Diego Garcia, which at 32.5 square kilometres (12.5 sq mi) accounts for about half of the territory's total land area.

Which countries are developing energy islands?

A number of early-stage energy island projects are being developed in European waters, led by Denmark and Belgium.

British Indian Ocean Territory (BIOT) lies about 1770 km east of Mahe (the main island of the Seychelles). The territory, an archipelago of 55 islands, covers some 54,400 sq km of ocean. The islands have a land area of only 60 sq km and 698 km of coastline. Diego Garcia, the largest and most southerly island, is 44 sq km.

British Indian Ocean Territory is centrally placed in the Indian Ocean, south of the Island of Maldives, about halfway between Indonesia and Madagascar. The central island, Diego Garcia, is a military facility off-limits to anyone not on an official visit. Still, some of the uninhabited outer islands can be visited by yachters with permission.

Diego Garcia is one of about 60 islands that make up the Chagos Archipelago or British Indian Ocean Territory (BIOT) - the last colony established by the UK by separating it from Mauritius in 1965.

The territory comprises the six atolls of the Chagos Archipelago with over 1,000 individual (tiny) islands having a total land area of 60 square kilometres. The largest island is Diego Garcia (area 44 km²), the site of a joint military facility of the United Kingdom and the United States. The National Arms of the British Indian Ocean Territory

The British Indian Ocean Territory (BIOT) is located about 1500 km from the southern tip of India, 3400 km east of Africa and 3000 km west of Indonesia. The territory comprises the 55 islands of the Chagos Archipelago. It consists of five atolls, including The Great Chagos Bank - the largest atoll in the world.
