How much local investment has TRIG made?

How many projects does trig invest in?

As of December 31, 2021, the TRIG portfolio includes 83 equity investments. These investments are in the UK, Republic of Ireland, France, Sweden, Germany, and Spain. The portfolio comprises 50 wind projects, 32 solar PV projects, and one battery storage project. Additionally, there is one mezzanine debt investment in a mixed portfolio.
