However, it's crucial to understand that while installing solar panels is legal, certain conditions must be met. For most domestic properties, solar panel installations are considered a "permitted development" and do not require planning permission, provided they respect certain size criteria.

Can I install solar panels if I don't meet building regulations?

Your local authority can also apply for a Confiscation Order to take away any money you've earned with your system - so there's absolutely no benefit to installing solar panels that don't meet building regulations. It's crucial that your solar installation follows all building regulations.

Can you put solar panels on a building?

Yes, if the installation falls under permitted development. However, if you live in a conservation area or world heritage site you can't put solar panels on the principal or side elevation walls of your house if it fronts a highway.
