All legal entities require the preparation of statutory documents, with the exception of partnerships and sole traders. No matter the type of company one decides to register in Liechtenstein, the following steps must be followed:

What is the minimum share capital for a company in Liechtenstein?

The minimum share capital for creating a public company in Liechtenstein is 50,000 euros, US dollars, or Swiss francs. The share capital can be in cash or kind and at least 25% of it must be deposited when the company is registered with the Companies Registrar in Liechtenstein.
