What happened to Saint Pierre & Miquelon?

1670 - France annexes the islands on which a few fishermen from France are encamped, naming them Saint Pierre and Miquelon. 1700S - Repeated English attacks see French settlers abandon the islands.

Where are Saint Pierre and Miquelon?

First settled by the French in the early 17th century, Saint Pierre and Miquelon are the sole remaining vestige of France's once vast North American possessions. They attained the status of an overseas collectivity in 2003. Visit the Definitions and Notes page to view a description of each topic.

How is Saint Pierre & Miquelon governed?

Citizens Directly Elect Representatives to a Local Autonomous Legislature - As an overseas collectivity of the French Republic, Saint Pierre and Miquelon governs itself through a unicameral territorial councilelected by absolute majority vote. This legislative body consists of 19 seats, 15 from Saint Pierre and four from Miquelon.

Does Saint-Pierre and Miquelon have a health care system?

The Health Care System Functions Well - Saint-Pierre and Miquelon boasts a universal health care system. Until 2015, pursuant to an agreement between France and Canada, islanders could seek medical treatment in St. John's, the capital of the Canadian province of Newfoundland and Labrador.
