The company employs more than 1,600 people. Consol Energy was originally created in 1860 as the Consolidation Coal Company after several small mining companies in Western Maryland decided to combine their operations.

Consol also maintains support services including Baltimore Marine Terminal and Land Division. Consol Energy's flagship operation is the Pennsylvania Mining Complex, which includes three large underground mines capable of producing approximately 28.5 million tons of coal per year.

In 2017, Consol Energy Inc. spun off from CNX Resources Group. Officially announced on November 29,2017, this move marked the start of Consol Energy Inc. operating as an independent, publicly traded company. In 2012 Consol began a test of injecting CO 2 into geologic formations. [citation needed]
