Why did Toyo solar go public in 2024?

In the first six months of 2024, Toyo Solar achieved a 3 GW manufacturing capacity, shipped 986 MW of solar cells, and posted revenues of \$138.1 million and net income of \$19.6 million. The company went public in the U.S. following the combination of Vietnam Sunergy Cell Co., a wholly-owned subsidiary of Toyo, and Blue World Acquisition Corp.
