Why is Moldova a partner country of the EU INOGATE energy programme?

Moldova is a partner country of the EU INOGATE energy programme because it supports sustainable energy developmentand is a part of projects of common and regional interest. The programme also aims to enhance energy security and convergence of member state energy markets on the basis of EU internal energy market principles.

Why was Energocom created in Moldova?

In 2022,Moldova created JSC Energocom initially for renewable power supplies. However,after Russia attacked Ukraine's electricity system,resulting in the suspension of electricity imports from Ukraine,Energocom became essential for improving Moldova's energy security. The European Bank for Reconstruction and Development (EBRD) provided Energocom with EUR300m to support this initiative.

Does Moldova have a new energy policy?

Moldova has committed to implement reforms embedded within the European Union's Third Energy Package, a suite of legislation adopted in 2009 aimed at creating integrated and competitive energy markets for natural gas and electricity.

Does Moldova buy natural gas from energocom & Gazprom?

Moldova's natural gas company Moldovagazwill start buying gas from domestic supplier Energocom while continuing to buy it from Russia's Gazprom ,the head of Moldovagaz said late on Saturday.

Who owns kuciurgan power plant in Moldova?

Russian energy giant Gazprom supplies the gas-operated Kuciurgan plant, which generates electricity that powers a significant portion of Moldova proper. The plant was privatised in 2004 by Transnistrian officials and later sold to a Russian state-owned company. Moldova doesn't recognise the privatisation.

Does Moldova have a natural gas monopoly?

Moldova made progress toward unbundling Moldovagaz, the vertically integrated natural gas monopoly, to comply with Third Energy Package requirements. Romania's Transgaz completed the Ungheni-Chisinau Pipeline in 2021 and took over the operation of the entire gas transmission network in September 2023.
