What is the Seychelles MSP process?

The Seychelles MSP process is the second largest in the world by area, and will be the first comprehensive MSP in the Western Indian Ocean. Phase 1 of the Seychelles MSP Initiative began in February 2014 and was completed in February 2018. Phase 1 included Milestone 1 and a marine protection goal of 15%.

What is the Seychelles Marine Spatial Planning initiative (MSP)?

The Seychelles Marine Spatial Planning (MSP) Initiative is a process focused on planning for and management of the sustainable and long-term use and health of the Seychelles Exclusive Economic Zone (EEZ). The EEZ covers 1,374,000 km2 of ocean and 115 islands.

How will the Seychelles MSP be implemented and regulated?

The Seychelles MSP will be implemented and regulated upon completion by developing a new Seychelles MSP Policy, an implementation plan, governance and legal frameworks supported by management plans, legislation and regulations.

What is Phase 1 of the Seychelles MSP initiative?

Phase 1 of the Seychelles MSP Initiative began in February 2014 and was completed in February 2018. Phase 1 included Milestone 1 and a marine protection goal of 15%. Two new marine protection areas were gazetted and officially designated: Zone 1 - Aldabra Group and Zone 2 - Amirantes to Fortune Bank.

What is the Seychelles Marine Plan?

The marine plan will ensure representative species and habitats have long-term protection, resiliency of coastal ecosystems with a changing climate, and ensure economic opportunities for fisheries, tourism and other uses by advancing the Seychelles' Blue Economy Roadmap.

Who is involved in the Seychelles Marine Plan development process?

The Seychelles Marine Plan development process has a robust stakeholder engagement framework and includes all major sectors of the Seychellessuch as commercial fishing, tourism and marine charters, biodiversity conservation, renewable energy, port authority, maritime safety, and no-renewable resources to develop a comprehensive marine plan with stakeholder input.

MSP Zoning Framework Marine spatial plans provide guidance for decision makers and of ocean space using a public, participatory approach to plan for the ocean and address multiple objectives: ecological, economic and social.

Seychelles" marine waters encompasses 1,350,000 square kilometres and 115 islands in four archipelagoes. The SMSP Initiative is a Government-led process, with planning and facilitation led by The Nature Conservancy (TNC) in partnership with GoS-UNDP-GEF Programme Coordinating Unit (PCU) and Seychelles Conservation and Climate Adaptation Trust ...

The MSP core team will prepare a marine plan in accordance with the governance framework for stakeholder consultations. In Phase 2, consultations with stakeholders, data collection and scientific analysis will allow for refining the zoning design and evaluating different scenarios with stakeholders in order to achieve economic and ecological ...

A legal roadmap was developed for a legally enforceable Marine Spatial Plan and an MSP implementation authority operationalized starting in 2022, the Seychelles Ocean Agency (SOA). The Marine Spatial Plan completion is planned for 2024, with implementation of the zoning areas to begin in 2025.
