What is the invest in Namibia energies Country Spotlight?

The Invest in Namibia Energies country spotlight represents just one of many spotlights set to take place during this year's edition of AEW. #AEW2023 takes place this week in Cape Town under a mandate to make energy poverty history by 2030.

What is happening in Namibia's energy sector?

Namibia's energy sector has seen rapid development in a short period of time owing to five recent major oil and gas discoveries, which include the Venus-1X, Graff-1X, Jonker-1X, La Rona-1X, and Lesedi-1X exploration projects.

What are the main energy sources in Namibia?

Namibia's main energy sources are petroleum, hydropower, imported electricity and imported coal. Currently, less than 50% of the population has access to power. The country's traditional generation capacity consists of a mix of hydropower, coal, diesel and thermal.

Will Namibia introduce nuclear power into its domestic mix?

Namibia has stated its interest in introducing nuclear power into its domestic mix. The desire (and need) to move away from the traditional energy mix, coupled with Namibia's potential for renewable energy generation, resulted in several reforms over the last few years aimed at attracting IPPs.

How will solar power benefit Namibia?

The generation of solar power will complement Namibia's available green energy portfolio, such as hydro-electricity, which already constitutes more than two-thirds of our installed power capacity. Electrifying key parts of our economy and of our neighbours will spur unprecedented economic activity and growth for Namibia and Southern Africa.

Can Namibia become a green energy supplier?

Already, our country is home to the largest desalination plant in Southern Africa, meaning that the conditions for producing abundant clean water in a desert country are conducive. Once Namibia has successfully incubated the green hydrogen economy, it will enable the country to become a supplier of energy, rather than an importer.

The required infrastructure for power trading already exists. About 40% of Namibia's power currently comes from South Africa and is primarily driven by coal-fired power plants. We imagine a reality where Namibia exports clean energy to South Africa thereby assisting the Southern African region to decarbonize.
