How long does it take to register a business in Nauru?

Term of registration of business in Nauru usually equals to two business daysfrom the moment when all the necessary documents are submitted to the registrar. Company name should be original and not similar to already existing names. The name can be registered in any language, but at the same time its translation into English is mandatory.

Can a resident company own real estate in Nauru?

Offshore company in Nauru has no rightto conduct commerce with residents of the jurisdiction and own real estate in Nauru. In addition, the resident company can not participate in the management of offshore company. Provision of services of registration agent for offshore company in Nauru to resident companies is prohibited.
