

What is New England Bess?

The New England BESS is being built through the support of the NSW Government's Emerging Energy Program. In 2023, ACEN Australia secured a 20 year Long Term Energy Service Agreement (LTESA) for New England Solar in the NSW Government's first renewable energy and storage auction.

What is the New England Bess project?

Currently supported by the NSW Government's Emerging Energy Program, the New England BESS project is a part of ACEN's broader strategy in Australia, where they are actively developing over 1 GW of projects.

What is the Bess & how will it impact New South Wales?

The BESS will improve system strength and grid reliability, allowing more low-cost renewable energy to connect to the grid, lowering prices for New South Wales consumers. In March 2022, Ayala group's listed energy platform, ACEN, increased its ownership in UPC\AC Renewables to 80%, with the intent to be at 100 % ownership by early 2023.

Earlier this year (15 April), the organisation confirmed that its 50MW/100MWh 2-hour duration Salisbury project became its first operational BESS. SSE Renewables is also constructing a 150MW battery project in Ferrybridge, West Yorkshire, which is due for completion in the first half of 2025.
