Does Puerto Rico have a new energy program?

ContinueClose Furthering the mitigation to future disasters,the Puerto Rico Department of Housing will be implementing the New Energy Program,designed to assist eligible households providing renewable energy installations,therefore mitigating the effects of Energy Lifeline failure or disruption.

Will Puerto Rico have a future energy system?

The future energy system in Puerto Rico can be affordable for the most vulnerable customers, resilient for the most remote communities, obliging of land-use interests, and supportive of distributed and local ownership.

What are the galvanizing forces affecting Puerto Rico's energy system?

Frequent and extreme weather events. Record-setting power outages. High energy costs. These are some of the galvanizing forces that unite the people of Puerto Rico in their commitment to achieve a more resilient,reliable,affordable energy system.

How much money does Puerto Rico have to pay for solar?

Up to \$190 million is available to Puerto Rico's Housing Administration and a private company to pay for solar and battery installations in public housing common areas and subsidized,multifamily housing properties. Another \$175 million is available for certain healthcare and dialysis centers.

What can Puerto Rico do if a hurricane hits the grid?

When hurricanes hit the grid,all energy system resources--including distributed and utility-scale renewables and energy storage--should participate in the recovery process. To make the PR100 findings more actionable for Puerto Rico,the team created an implementation roadmap with considerations for how Puerto Rico can reach its objectives.

Why did Puerto Rico get a power outage?

The announcement comes as the U.S. territory continues to struggle with chronic power outages that have worsened since Hurricane Mariapummeled the island as a powerful Category 4 storm in 2017,razing the electric grid. The outages also are blamed on a lack of maintenance and investment in its electric grid for decades.
