Does Johnson Matthey own OXIS Energy Limited?

Johnson Matthey has acquired the assets and intellectual property of Oxis Energy Limited, a lithium-sulfur battery developer with assets that can be adapted for the manufacturing of components for green hydrogen production. The company, based near Oxford, UK, entered administration on 19 May 2021.

Who owns Axion battery systems?

In October 2012 Axion was acquired in total by Johnson Matthey, a British multinational chemicals and precious metals company headquartered in London, United Kingdom, which is listed on the London Stock Exchange and is a constituent of the FTSE 100 Index. Axion rebranded as Johnson Matthey Battery Systems in August 2013.
