

Penstock energy limited Montenegro

The federal government has completed the transfer of the operations of the Zungeru Hydroelectric Power Plant (ZHPP) to a concessionaire, Penstock Limited, in a move that will see the country earn \$70 million yearly from the deal.

At the meeting, the NCP announced significant progress in the Zungeru Hydroelectric Power Plant (ZHPP) concession, including the official transfer of the plant's operations to Penstock Limited. The Concession Agreement was signed on December 13, 2023, by the Bureau of Public Enterprises (BPE) and Penstock Limited.

Mainstream Energy Solutions Limited (MESL) was established in 2011 and licensed as a power-generating company. Through a concession agreement with the Federal Government of Nigeria, MESL acquired the Kainji and Jebba Hydro Plants (HPP) in November 2013, with a combined installed capacity of 1,338.4 MW.

The Federal Government has formally handed over the operations of the \$1.3 billion Zungeru Hydroelectric Power Plant to Penstock Limited.. The announcement was made on Tuesday at the inaugural 2024 session of the National Council on Privatisation (NCP), held at the Presidential Villa in Abuja.
