Does Drax have a multi-year supply deal with pathway energy?

British power company Drax said on Thursday it had reached an agreement on the terms of a multi-year supply deal of biomass pellets for Pathway Energy's proposed sustainable aviation fuel project in the United States.

How much energy does Drax produce?

The Drax power station currently has four biomass generating units and produces about 4% of Britain's power and 9% of its renewable electricity. BECCS is currently the only credible large-scale technology that can both remove carbon and generate renewable power.

What happened to Drax Power Station?

One significant change was the emergence of vertically integrated companies, combining generation, distribution and supply interests. In certain cases, it became necessary for generation assets to be divested, and so in 1999 Drax Power Station was acquired by the US-based AES Corporation for £1.87 billion (US\$3 billion).

Did Drax buy Opus Energy?

In 2016, Drax Group acquired Opus Energy for £340 million funded by a new acquisition debt facility of up to £375 million. In October 2017, Drax sold Billington Bioenergy for £2 million to an AIM-listed energy company called Aggregated Micro Power Holdings.

The plant's operator, Drax Power, has been working to improve its environmental performance by gradually making the switch from coal-fired generation to biomass. The operator announced a £700m project to convert three of its six generating units to biomass in 2012, with two of the three units now converted and the third set to complete its ...
