Solx has signed a 10-year lease with potential extensions on the 150,000-ft 2 building on HP's 65-acre campus. The company is investing \$20 million into the facility to get it ready for panel manufacturing. Siting a panel manufacturer in Puerto Rico was always the goal for Solx.

Why should Puerto Rico invest in solx solar?
