Will Biden pay \$440 million to install solar panels in Puerto Rico?

The Biden administration announced Thursday that it will pay \$440 million to install solar panels in Puerto Rico. The Department of Energy (DOE) made the announcement Thursday, saying that the funding will lower energy costs for 30,000 to 40,000 single-family households in Puerto Rico and help improve the resilience of energy sources.

What is the Puerto Rico solar access program?

The Solar Access Program is funded by the U.S. Department of Energy's Puerto Rico Energy Resilience Fund. For far too long, Puerto Ricans have lived with an unreliable and expensive electric system.

What is the Puerto Rico energy Resilience Fund?

This program, funded through the Puerto Rico Energy Resilience Fund, will provide solar panels and battery storage systems to low-income households in Puerto Rico with zero upfront costs, as well as education and support on how to use and maintain the systems.
