Kingdom of Bhutan, 2000, the Ministry of Finance (MoF) hereby frames the following rules on Bhutan Sales Tax, Customs and Excise duties. The rules have been framed only where the Ministry of Finance is empowered by the Act. All references to Parts and Sections in these rules pertain to the Act and must be read together with the Act.

Bhutan, 2001". COMMENCEMENT 2. This Act shall come into effect from the 26 th day of the 5 th month of the Female Iron Snake Year corresponding to 17 July, 2001. TERRITORIAL EXTENT 3. This Act shall extend to the whole of the Kingdom of Bhutan. SCOPE 4. Unless the context otherwise requires, this Act applies only to transactions in goods. It
