How much is TransAlta renewables worth?

The deal would reverse its decision to spin off TransAlta Renewables in 2013. The power utility says the total consideration to be paid to TransAlta Renewables shareholders for the 40 per cent stake it does not already own is valued at \$1.38 billion.

Does TransAlta own RNW?

Under the Arrangement, TransAlta acquired all of the outstanding common shares of RNW (each, a "RNW Share") not already owned, directly or indirectly, by TransAlta and certain of its affiliates, resulting in RNW becoming a wholly owned subsidiary of TransAlta.

TransAlta Renewable shares closed at \$10.99 on the Toronto Stock Exchange on Monday before the deal was announced. TransAlta chief executive John Kousinioris says the combined company's greater scale and enhanced positioning will drive benefits and unlock value for shareholders.
