What is the Senate of Trinidad & Tobago?

The Senate of Trinidad and Tobago is the appointed upper house of the bicameral Parliament of Trinidad and Tobago, along with the President and House of Representatives of Trinidad and Tobago. The Senate currently sits at the Red House.

Who owns power generation in Trinidad & Tobago?

Power Generation Company of Trinidad and Tobago (POWERGEN) Ownership: In 1994, T&TEC divested its generation assets to POWERGEN, a company whose ownership structure at the time was led by T&TEC with a 51 percent shareholding, followed by Southern Electric International with 39 percent and Amoco with 10 percent.
