How did Morocco and Mauritania annex Western Sahara?

The accords were based on a bipartite administration, and Morocco and Mauritania each moved to annex the territories, with Morocco taking control of the northern two-thirds of Western Sahara as its Southern Provinces, and Mauritania taking control of the southern third as Tiris al-Gharbiyya.

Which country controls Western Sahara?

Moroccocontrols territory to the west of the berm (border wall) while the Sahrawi Republic controls territory to the east (see map on right). Western Sahara was partitioned between Morocco and Mauritania in April 1976, with Morocco acquiring the northern two-thirds of the territory.

Is Western Sahara a disputed territory?

Western Sahara[a]is a disputed territoryin North-western Africa. It has a surface area of 272,000 square kilometres (105,000 sq mi). Approximately 30% of the territory (82,500 km 2 (31,900 sq mi)) is controlled by the Sahrawi Arab Democratic Republic (SADR); the remaining 70% is occupied and administered by neighboring Morocco.

Western Sahara's economy is based almost entirely on fishing, which employs two-thirds of its workforce, with mining, agriculture and tourism providing modest additional income. Most food for the urban population comes from Morocco.
